By signing and dating this acknowledgment form, I am certifying that I am authorized to make this application, and that I have read and understand the following standards for alcohol sales in the City of Sugar Land:

Any business establishment with alcohol sales that exceed 49% of total sales revenues is considered a Drinking Place. Drinking Places are not permitted in any of the City's primary zoning districts, as established in the City of Sugar Land Development Code Sec. 2-51.

Except within a Planned Development (PD) district where Drinking Places are authorized, no business establishment shall have alcohol sales in excess of 49% of total sales revenue. Whether a food establishment or other business that serves alcohol, revenues from food, merchandise, or activities must be a minimum of 51% of gross sales. The City may request sales receipts to verify compliance with this requirement at any time.

This acknowledgement does not replace other local or state requirements for alcohol sales.
